Financial Assistance Grants Available Beginning Thursday, May 7th at 8 am

Beginning on May 7, several grants will be available to families, small businesses, non-profits, health service centers and individuals impacted by COVID19. Montanans out of work, families with limited resources, small businesses, non-profits and others can apply for financial relief for things like rental and mortgage assistance, business and non-profit grants, grants to serve seniors and those living with a disability, food banks and local food producers.

- The application portal opens tomorrow, May 7 at 8:00 a.m. Apply at covidrelief.mt.gov.

To prepare for the application, **businesses and non-profits** should have their tax ID, proof of business registration, a brief description of how the grant will be spent, and a brief description of how COVID-19 has impacted operations. **Homeowners and renters** should have bank account information available and verification of job or income loss.
