With the Baccalaureate services, a feature of this coming Sunday evening, the high school will commence the 33<sup>rd</sup> Commencement week. The Baccalaureate sermon will be preached by the Rev. John W. Kuller of the Townsend Methodist Episcopal Church in the gymnasium of the school the program of which will commence at 8:00 o'clock, the title of which is “The Mind of Christ”, the program to include hymns, music by the school's glee club.

Commencement exercises will be held on Friday evening, May 29<sup>th</sup> and will mark the closing of a very successful year under the supervision of W.L. Emmert who closes his first term as head of the school. ### **“Townsend Boys Take Order from Hobo at Point of Gun”**

Four Townsend boys were kidnapped in their own car, three later liberated and the fourth taken for a longer ride last Sunday in Helena. After getting together again and talking things over they decided they had been kidnapped and hadn't been kidnapped and really didn't know what to think, things happened so fast. All agreed that Mongrain came the nearest to being bumped off than any of them and before the fright of the situation subsided they could all feel the gags over their mouths, their eyes blind folded and suffering somewhat from lack of food, water and mistreatment at the hands of real desperadoes.

It all came about when they started for Missoula last Sunday. In the party were Donald Whaley, Stanley Mongrain, Bill Stiner and Willard Lofgren. They left Townsend early Sunday morning for Missoula and had stopped at the Hamburger Inn in Helena for breakfast, according to the story, when a fellow accosted them just after they were finished, asking them where they were going. Upon being told they were headed for Missoula he remarked that that was just where he wanted to go and intended to go with them. Upon refusing the request for transportation giving as excuses they were crowded as it was and didn't want any more passengers, the stranger drew an automatic pistol from a shoulder holster and the gun talked louder and more forcibly than words. Needless to say the stranger went along.

The party started for their destination. At a point beyond the Broadwater natatorium the “Boss” of the party told three of the youths to get out and then continued with Stanley Mongrain. The three got back to Helena by a passing motorist. The “pseudo kidnapper” and Mongrain continued toward Missoula for a few miles farther when the supposed desperado decided to return to Helena. At Lyndale and Benton, the Kidnapper got out and took the

jungles along the Great Northern tracks. Mongrain went to the Police station to report the incident and there was joined again by his party.

The stranger made no attempt to rob or take the car of the boys and officers were at a loss what was the motive.

A search was quickly organized by Helena officers and members of the state highway patrol, but no trace of him was found. He was described as a man of slender build with thin unshaven face, about 5 feet 7 inches tall and weighing about 135 pounds.
