Montana Has 4 Reported COVID19 Deaths

Toole County Health officials report two county residents have died. In addition, Madison County officials report a death of a Madison County resident from the virus. Today Montana has 171 reported cases. The hotspots county is Gallatin (67) and Yellowstone (26) with 54 % of the state total. Missoula County now has 12 confirmed case and Lewis and Clark County with a 11 case.

Patient Recovery Stats Unknown

At this time, the state of Montana has not provided any public information on how many Montanan's have recovered from the coronavirus or COVID19 illness.

City public works crew is staggering shifts to ensure essential services – drinking water, sewer service, trash collection – continue throughout the COVID19 pandemic. City office crew are continuing to work and are available by telephone contact 266-3911. City utility bills will continue to go out, please continue to pay for your monthly services, however, if you have difficultly due to a layoff or financial difficulties, please contact the City Office for arrangements. Mayor Evans stated that no services will be cutoff for nonpayment during the COVID19 emergency.

Townsend Schools – Class Schedule Update

Monday, March 30, 2020, the School District transitioned to a virtual school day with the goal to provide quality instruction, as well as create a more structured format.

- The class schedule for **Grades 3-12** are posted on the Townsend School's website, Townsend Schools Facebook Page, and each teacher's Google Classroom Page.
 - Students will log in and attend virtual class.
 - Attendance will be taken and work will be required in much the same way as we would in a physical school.
- The schedule for Grades K-2 are provided each teacher's Google Classroom and Class Dojo, as
 those in early elementary will operate under a slightly different schedule appropriate for the age
 level.
 - Kindergarten learning packets will be available Friday morning and can be picked up at any of the lunch pickup locations.
 - Attendance will be taken and work will be required in much the same way as we would in a physical school.
- If students or parents are experiencing difficulties with access, lessons, or devices, please contact your teacher through the digital platform or contact the school and we will do our best to assist you.

Free Breakfast & Lunch For All Kids

- Townsend Schools K-12 are providing free grab and go breakfast and lunch bags (Monday thru Friday) for all children ages zero to eighteen (not just students).
- In Townsend kids can obtain grab and go breakfasts and lunches at the playground backdoor of the School lunchroom on North Pine St. from 7:30 a.m. to 9:30 a.m. Monday thru Friday.
 - Students can also pick up school Chromebooks at the lunchroom from 7:30 am to 9:30 am
 M-F.
- For out-of-town children/youth, the grab and go meals will be delivered Monday thru Friday to the following locations:
 - Winston Fire Station from 8:30-10:00 am M-F
 - Duck Creek Fire Station from 8:30-10:00 am M-F
 - Toston Fire Station from 8:30-9:30 am M-F
