#### **Montana Summary**

GREAT NEWS HERE IN MONTANA, NO NEW COVID CASES REPORTED WITHIN THE LAST 24-HOURS. As of April 20, 2020, at 10:30 AM a total of 433 individuals have tested positive in Montana. No additional deaths reported.

- 433 total tested positive in Montana
- 243 Montanans have recovered
- 190 active cases currently
- 19 currently hospitalized
- 57 total hospitalizations to date
- 10 fatalities to date in Montana as a result of COVID19

 detail to clarify essential workers; emphasis
 for Emergency Medical Services workers;
 and adds lawyers and legal aid workers.

#### **Link to Federal Assistance Programs**

Through the Coronavirus Relief Fund, the CARES Act provides for payments to State, Local, and Tribal governments navigating the impact of the COVID-19 outbreak. The CARES Act established the \$150 billion Coronavirus Relief Fund. Treasury will make payments from the Fund to States and eligible units of local government; the District of Columbia and U.S. Territories.

- The CARES Act requires that the payments from the Coronavirus Relief Fund only be used to cover expenses that—
  - (1) Are necessary expenditures incurred due to the public health emergency with respect to the Coronavirus Disease 2019 (COVID–19)?
  - (2) Were not accounted for in the budget most recently approved as of Mar 27, 2020 (the date of enactment of the CARES Act) for the State or government; and
  - (3) Were incurred during the period that begins on Mar 1, 2020, and ends on Dec 30, 2020.
- Amounts paid to States, the District of Columbia, U.S. Territories, and eligible units of local
  government are based on population as provided in the CARES Act. The CARES Act directs Treasury
  to use U.S. Census Bureau data for the most recent year for which data is available. The amount of
  payments made to each State will be reduced by the aggregate amount of payments that will be
  disbursed to eligible local governments within such State that have provided the required
  certifications to Treasury.
- A unit of local government eligible for receipt of direct payment includes a county, municipality, town, township, village, parish, borough, or other unit of general government below the State level with a population that exceeds 500,000.

#### **Clean and Disinfect Guidelines**

Clean AND disinfect frequently touched surfaces daily. This includes tables, doorknobs, light switches, countertops, handles, desks, phones, keyboards, toilets, faucets, and sinks. If surfaces are dirty, clean **them:** Use detergent or soap and water prior to disinfection.

- To disinfect:
  - Most common EPA-registered household disinfectants will work.
- Diluting your household bleach.

To make a bleach solution, mix:

- > 5 tablespoons (1/3rd cup) bleach per gallon of water
- 4 teaspoons bleach per quart of water

Follow manufacturer's instructions for application and proper ventilation. Check to ensure the product is not past its expiration date. Never mix household bleach with ammonia or any other cleanser. Unexpired household bleach will be effective against coronaviruses when properly diluted.

Alcohol solutions.

Ensure solution has at least 70% alcohol.
