<u>Critical Care Decontamination System for N95 Respirators</u>

Montana has received a Battelle Critical Care Decontamination System to be used in cleaning and disinfecting used N95 respirators. The system can decontaminate 80,000 used N95 respirators per day and a single respirator can be reused up to 20 times without degradation. To get N95 respirators cleaned, health care providers must first fill out an enrollment form at battelle.org/decon. Battelle will return an email with links to the enrollment contract, instructions and the Battelle point of contact. Shipping is at no cost if arranged through Battelle and FedEx.

Broadwater County Issues Guidelines to Reopen Businesses

The Broadwater County Environmental Health Officer, Shawn Rowland, issued specific guidelines for certain local business establishments to be eligibility to reopen and service customers. Two specific sets of guidelines are identified as follows:

- Bars, Brew Pubs, Wineries, Casinos, and Food Service Operations to Dine-in Customers, and
- Personal Care Services: Salons, Massage, Body Art, and Other Establishments
