Please describe what area the airports serves and any special roles or functions it may also provide:

The Townsend Airport is used by the typical mix of light aircraft for government, business, and recreational purposes. The airport has seen increased usage over the past several years, in part by 2 aviation businesses. A 24-hour self-serve fueling system provides both a revenue generation to the airport, and a draw in traffic to the airport. The Townsend Airport is regularly used for landing practice by students from both Bozeman and Helena. It is seasonally utilized both for agricultural operations and fire fighting operations. It serves as a seasonal base for aerial fire fighting operations. It provides a weather and emergency alternate for light aircraft flying between Helena and Bozeman. Townsend is often clear on days when the Helena Valley is fogged in, allowing government, business, and express mail/cargo flights to wait-out the inclement weather safely on the ground.

Please describe the need, urgency and support for this project:

The Townsend Airport pavements are 19 years past an overlay, and 28 years past their original construction in 1993 (taxilanes constructed in 2002). While the pavement have performed well, they are in need of a major rehabilitation / reconstruction effort. The reflective cracks through the overlay are getting very wide, and new cracking is begging to be fairly widespread. They have reached a point where the airport must transition to a reconstruction effort over maintenance. This Phase I - Design effort will complete geotechnical investigations, site surveying, and preliminary design so that accurate preliminary cost estimates and construction recommendation can be made. This will also for the FAA and Owner to budget for the necessary improvements scheduled to occur in 2022 or 2023 (FAA funding dependent).

Additional comments for airport finances. (Optional)

Broadwater County typically assesses 1 mill for the airport (about \$15,000 annually). Additional revenue comes from land leases, hangar ground leases, fuel sales, hay sales, miscellaneous tax revenue and interest income. Much of the above revenue and expenses are for fuel purchases / sales. The City of Townsend via an inter-local agreement with the County contributes approximately \$14,000 annually for general airport maintenance, with all the finances administered by the County. The Townsend Airport has worked diligently to maintain and lengthen the life of their pavements, while trying to save local matching funds for next years anticipated approximate \$4M project requiring a \$400,000 local share. They would appreciate any assistance Montana Aeronautics can give towards this preliminary engineering project. Broadwater County also owns and operates the Canyon Ferry Airport.
