Broadwater County will be accepting sealed responses from qualified contractors for a CCTV system at the address 515 Broadway, Townsend, MT 59644. Broadwater County seeks the services to upgrade DVR system, cleanup camera wiring, label and organize camera wires, replace camera with audio in booking, install one new camera in sheriff's lobby, and install six cameras at the entrances for the courthouse. Subrecipients may not use any FEMA funds to procure or obtain China made or China affiliated telecommunication, video surveillance equipment or services. MCA 18-2-401, defines a public works contract as a contract for construction services let by the state, county, municipality, school district, or political subdivision or for non-construction services let by the state, county, municipality, or political subdivision in which the total cost of the contract is in excess of \$25,000. If the total cost of the contract exceeds \$25,000, standard prevailing rate of wages for building construction services would apply according to MCA 18-2-413. MCA 18-2-403 also requires the contractor to give preference to the employment of bona fide Montana residents in the performance of the work. MCA 18-2-403 sets forth several obligations regarding public works contracts that each contractor should understand and consider when submitting their proposal.

Each bidder will be required to have a valid Montana Public Contractors License. All bids are to contain and state Davis Bacon wages. After award the successful bidder must furnish an approved performance security and a Labor & Material Payment Security each in the amount of 100% of the contract.
Subcontractors will be required to hold a Montana Public Contractor's License and will be expected to comply with all fair labor practices and must meet the requirements of applicable State statues.
No bidder shall withdraw his bid for at least 30 days after the scheduled time for receipt.
The Owner reserves the right to reject any or all bids and to waive any and all irregularities or informalities and the right to determine what constitutes any and all irregularities or informalities.
No bidder may withdraw his proposal for at least thirty days (30) after the scheduled time for receipt of proposals.
The County reserves the right to accept or reject any or all proposals and to waive any irregularities or informalities.
