County employees spend a significant amount of time engaged with local management and project activities on both public and private lands. While their salaries are covered by the county travel expenses are a big component of their expenses. Covering these expenses helps facilitate a higher amount of engagement and better consistent participation in helping with county input into projects. This higher level of participation and coordination certainly facilitates the pace and thoroughness of projects. It helps build a stronger partnership between the county and the partnering agencies.

Requested Grant coverage:

18 travel days with 1340 miles at \$.56/mi = \$750.40

Daily per diem rate of \$30.50 for 18 days =\$549.00

Motel room for 5 nights = \$480.00

Attendance at MACO forestry sessions by the three commissioners (1 day, 3 commissioners in Helena), annual coordination meetings and project meetings with the local Forest Service, Bureau of Land Management and State Lands offices (1 day each coordination travel, 2 days each on project meetings and field trips, travel). DES, Planning and Weed coordinator county staff meet several times a year with agency partners to attend or plan and conduct meetings and field trips as a partner (3 staff meeting 2 days per year, travel).

County match for 18 days salary = \$2880
