
Hello Everyone,

What is the American Legion All About?

The American Legion was chartered and incorporated by Congress in 1919 as a patriotic veterans organization devoted to mutual helpfulness. As a 501(c)19 Non-profit Veterans Service Organization, it's Family consists of the American Legion, the American Legion Auxiliary, Sons of the Legion and American Legion Riders. All four of these organizations serve Veterans and their families, first and foremost and combined comprise over three million members worldwide. Townsend's Broadwater Post 42 followed National suit quickly to form and charter a local Post in 1919 as well, so we're 102 years old. Within our Post we have representation of all four Community as a whole because we all benefit when our Community succeeds. Our local programs and services for Veterans, their families and our Community are briefly touched on be-

Did you know we will coordinate the Honors and provide the reception for any Veteran death in Broadwater County at no charge to the family, if requested? This is a service from us regardless of whether the Veteran or their family members were American Legion connected. Our Auxiliary will also provide the reception for a Veteran's deceased spouse or children free of charge. Keep us in mind and let us help ease some of the pressure that you undoubtedly will have upon a loved one's passing.

If you know of a Veteran who is experiencing homelessness, or possible eviction, struggling financially from an unexpected situation, please let us know. We have a support network and access to emergency funds that may be able to provide temporary relief until more permanent solutions can be found.

Did you know that our local Post 42 has some medical equipment such as crutches, walkers, canes and more that can be loaned or given to a Veteran's family as needed?

Are you deploying overseas or know of a local who is on temporary assignment out of country? We send deployers 'hugs from home' in the way of care packages with local flair sponsored by local businesses and County support.

Do you have or know of a High School senior looking for financial Submitted by Jen Dalrymple help for higher education? We offer a competitive yearly \$500 scholarship to a graduating senior for use at any institution of higher learning to include trade or vocational schools. The scholarship can be held for the deserving student for up to two years following their graduation. Speaking of scholarships, we, along with the Lions and Rotary clubs, sponsor High School juniors to attend Legion Boys State and Auxiliary Girls State sessions each year where they

participate in mock government from the local to National level and learn about how to develop, present and defend bills in the mock legislature or participate in mock trials during judicial proceedings. Patriotism or "love of country" is a foundation of most Veterans organizations and the students visit Veterans hospitals/ homes, learn about opportunities to serve in the military and partake in flag-raising ceremonies.

If you love the patriotic American flags on Main Street, thank the business owners who support us to put them up. We now keep them flying year round and most of the local businesses offer financial support to purchase the flags for this Patriotic display. If you would like to purchase a personal flag for yourself, or help support the Post or Community with their flags, consider purchasing your flag through our Post flag program. We order flags in bulk and our Post receives credit those purchased through The American Legion Flag and Emblem Store. The local ladies quilting group assists us by double hemming the flags purchased so they can withstand the winds so common here.

Another commonality here are the hard working First Responders and our Post Family raises thousands of dollars each year during the funspirational 9/11 Patriots Day dinner to support their emerging needs such as the search and rescue drone purchase, Sheriff's organizations who strive to not only serve our Veterans but the tire puncture strips, outfitting a police bicycle, purchasing equipment for the new ambulance and much more. It all takes Community support and we're very fortunate to have that.

> A popular fundraiser around town each May is the American Legion Auxiliary's Poppy Drive. Our members sell the paper-mâché red poppies (a symbol of both Remembrance and Hope for a peaceful future) for donations to help support Veteran programs. The Auxiliary also engages the school in the Poppy Poster Contest where several award winning students' works of art have been featured at both State and National levels, earning them monetary awards for their efforts.

> In November, the Legion Surf 'n' Turf Dinner brings in a crowd for a feast of whole Maine Lobsters, local steaks and community fellowship to support the renovation, construction and upkeep of our 1890's Legion Hall and club.

> Many of our members also offer labor assistance to many other organizations in the Community as a way to give back and to preserve the blessings of what we have here at home.

> These are but a few of the many and varied services we provide to Veterans, their families and this Community. Townsend Skatepark Project

A lot has been going on since our last newsletter. The Skatepark now has a definite site, Holloway Park. Our City Council decided there would be the best place for the skatepark, approving up to 4500 sqft for the project. We have secured \$150,000 plus an additional \$1700 from Carla Amundsen's 1990's initial skatepark effort. Of the \$150,000, \$50,000 comes from Jeff Ament (MT Pool Service), \$50,000 from the Montana Skatepark Association, and \$50,000 from our local Broadwater County Trust Board. We are very thankful for each of these contributors and hope to see each of them at the grand opening after completion this spring. The skatepark was to be completed by the end of October but due to project overbooking, Evergreen Skateparks' owner and operator Billy Coulon has requested a later start date. It seems he had not been sleeping well, trying to figure out how he was going to get all of his projects done in the time period he had allotted. We regrettably agreed to postpone our skatepark with assurances that it will happen in the spring and that will definitely bring his A team then. Please everyone, hope for an early spring. In reality, a later start date will allow us to maybe garner up a few more funds and resolve some logistical issues. As it stands now, our funds will give us approximately, a 4275 sqft skatepark. I estimate that if we could garner an additional \$8000 - \$10000 more, we could achieve that 4500 sqft footprint that we are allowed. As Billy says, at this point, every dollar counts towards a better skating experience.

Jeff Ament

Some notes on Jeff Ament, a contributor. Jeff is one of the initial starters and bass player of the band Pearl Jam who many of you may have heard of. Jeff grew up in Big Sandy, MT. Skateboarding gave him a means to recreate without following the path of drugs and alcohol that seemed to be the only recreation in Big Sandy. Jeff has financed or helped finance many (over ten) skateparks in Montana, helping this state to have more world class skateparks than any other state in the nation, according to a recent New York Times article. Jeff's skatepark contributions have all been to help the kids, especially the ones who don't always fit in. Many a youth have been saved from the wrong way of life with a skatepark near and he is continuing that compassion for kids with us. Jeff would like to put a skatepark in every town in Montana. Just google Jeff Ament and skateparks and you will find some very heart rendering videos and articles on his benevolence and insight.

As of this writing, STOKE is proposing to host Snapology at the Lodge, in agreement with the Townsend School District, in an after school environment. Snapology is a fast growing, continued learning experience for school aged children through the age of fourteen utilizing Legos as the basis for their learning adventure. The company has developed many science and technology (STEAM) based programs using Legos to build such devices as robots, carnival equipment, and motorized novelties. The kids have fun while learning many skills such as applied math, science and problem solving. Snapology is also the fastest growing company in its field. We are excited to be able to host this experience right here in Townsend.

Broadwater Community Foundation

In 1993, The Broadwater County Development Corporation (BCDC) attempted to obtain tax-exempt status for contributions. Unfortunately, the Internal Revenue Service denied the request leaving the county with no organization able to accept charitable contributions with a tax benefit to donors.

Soon after, Steve Browning discussed the Montana Community Foundation and its unique ability to accept charitable gifts for community benefit at a visioning meeting. Bill Kearns and Dalyce Flynn decided that the organization was just what Broadwater County needed. They met with several local service groups including the Lions, the Rotary, the Chamber of Commerce, and began laying the groundwork for the Broadwater Community Foundation.

The Broadwater Community Foundation was officially formed in 1995 with a loose knit group of board members consisting of Bill Kearns, Dalyce Flynn, Brian Patrick, Terry Nugent, Barbara Schaffer, Dennis Delwo, and Lanny White. This group started working on an informational pamphlet featuring a tree as the main symbol for the organization. A tree was selected because it starts as a small sapling much like the community foundation. In the future, the sapling would grow into a large tree that would protect and nourish everything around it.

In 1996, donations were used to finance a countywide mailing of the informational pamphlet. The mailing brought in nearly \$4000 to deposit into the Broadwater account. This amount was matched by the Montana Community Foundation to establish an endowment.

In 1997, the Broadwater Community Foundation expanded youth involvement when two student members were added to the board of directors. The foundation found itself able to make its first contributions back into the community in the form of scholarships. The first scholarships were in the amount of \$100.

The Broadwater Community Foundation experienced a lack of administrative funds in 1998. At that time, the board decided to sponsor a raffle to increase funds designated for expenses such as mailing and printing. BCF approached school organizations to help sell raffle tickets. Community businesses were bountiful in their donations and the raffle was well supported by the ticket buyers. The Montana Community Foundation matched the funds dollar-fordollar. The State Bank of Townsend also contributed \$10,000.

In 1999, several groups began using the BCF as the umbrella for their projects including the Canton Church restoration project and the Broadwater County Museum. In addition, the board provided \$1400 in grants to the community. Two \$200 scholarships were given as well as \$350 grants that were awarded to the Canton Church, the Broadwater County Museum, and the Broadwater County Hospital.

In 1999, the Broadwater Community Foundation initiated a fundraising activity called the "Light of Love". This is a memorial that is funded with donations in memory of deceased relative and friends. It is held in December. A Christmas tree is set up in a business during the season with ornaments naming the deceased.

The BCF began another fundraising activity in 2005. This was a wine and cheese tasting event with artists doing "quick Draw" paintings during the evening. Their artworks were auctioned off at the end of the evening. After 6 years, this event continued with the wine and cheese tasting but also featured a "casino-night" activity. Guests gambled with play money, bid on silent auction items and redeemed their play money on a play-money silent auction. Besides being an enjoyable evening, the evening was a success.

In 2011, BCF offered sponsorships to the public via our newsletter. This included four categories: Bronze, which costs \$25.00, Silver @ \$50.00, Gold @ \$100.00, and Platinum @ \$500.00. In our first year, we collected \$3200. In 2014, we collected over \$10,000.

Since its inception, the Broadwater Community Foundation has granted over \$161,000.00, which has helped many nonprofit organizations with their projects. At the present time, BCF has eight active board members. We have decided to dispense with student board members due to scheduling conflicts with meetings and BCF activities.

Our Vision: A community that is preserved and enriched by the efforts of the Broadwater Community Foundation.

Broadband for Broadwater

Broadwater County has the opportunity to make a considerable improvement to their broadband coverage. Currently our county ranks near last in Montana for wired high-speed low-cost internet. Our commissioners will be spearheading an effort to pursue a grant from the Connect MT Act. This is \$275 million the state has set aside for the expansion of reliable internet into underserved and unserved areas.

As of this writing the communications committee at the state level is just pulling together the process for applying for the funds. We collectively as Broadwater County need to pull together to support this effort. More information is available at ARPA.mt.gov/communications. It is also researching SB297.

As this project moves ahead it would be good to form a coalition of the school, health care, first responders, AG, and economic development. We need to promote running quality broadband to the last mile (your house) for everyone in the entire county.

The Broadwater Educational Foundation would like to take this opportunity to thank this generous community for all the donations, memorials, memberships, various support, and participation in trivia nights and other fundraising efforts.
