Hello Everyone. I hope everyone had a great start to 2024.



a terrific way to celebrate the In the Montana History books, very little is mentioned about the rich history of the Missouri Valley and of Broadwater County. The purpose of the fieldtrip is to teach students about the history of what is now Broadwater County. First, we cover the history of the historic Canton Church; then we move onto the history of the county including the towns of Diamond City, Radersburg, Hassle, Toston, Winston, Lombard, and of course Townsend. We also talk about the colorful towns of Hogem, Beatem and Cheatem!

> After the history presentation the Canton Church board members treat the students to a lunch of hamburgers, hotdogs, chips, cookies and water - the students' favorite part of the trip!

DEEP CREEK CEMETERY

Most individuals never think of a cemetery or even visit one until they lose a loved one or know of someone who is buried in one. It is nice to know that residents in Townsend are blessed to have one that is beautiful to accommodate a family's needs.



The Deep Creek Cemetery has served families locally, those from nearby communities, and from out of state as well. To improve the record keeping of the cemetery, the board reviewed all the graves in 2023 to update the directory and created a website (deepcreekcemetery.com) that allows one to search for a grave along with providing some history of the cemetery. A big thank you to Roger Flynn for donating his time to design and implement this new website for us. New markers were also installed to make marking graves easier in Sections I-L and an anonymous donor donated a new traveling irrigation wheel to help keep the cemetery green and eliminate moving some of the hand lines for the caretaker.

Memorial Day weekend in 2023 found the Rough Riders 4-H club helping visitors locate graves, providing information on the cemetery, and accepting donations. A big thank you to leader Pam McDonald and the Rough Riders!

So, as we head into 2024, the cemetery needs your help. First of all, there are many graves that are reserved in a family's name and have not been used in over 40, 50 or more years. We have tried to locate these families or relatives to determine the future use of the graves but have been unsuccessful. Therefore, later this spring, we will send out a list of the names in the hope we can solve some of these mysteries.

Secondly, the cost of operating the cemetery is becoming more expensive. The income used to pay for operating costs comes from money saved over the years from selling graves and donations. However, the cemetery's costs are exceeding the income from selling graves and from donations. To clarify the misconception of tax dollars for operating the cemetery, the cemetery does not receive any tax dollars from the county for its operations.

Therefore, as the cemetery prepares for the 2024 season, any amount that you could contribute to help offset the operating costs of the cemetery would be most appreciated and a tax donation receipt can be provided as well upon request. If you are one of those individuals who have to take an RMD (required minimum distribution) from your IRA or investment portfolio, please remember the cemetery is a 501c13 and your contribution. RHPI, Preserve Broadwater History and the Broadwater County Museum came together in May to host the 3rd annual Middle School students' history field trip to historic Radersburg. Preserve Broadwater History organizes the event, RHPI opens the school for the event and Broadwater County Museum Curator, Linda Huth, makes a presentation about the history of Radersburg. The students love getting out of school for a field trip and Linda Huth presents a really fun history of Radersburg. Preserve Broadwater History then feeds the kids a lunch of hamburgers, hotdogs, chips, and water – probably the most favorite part of the fieldtrip!

After lunch the students visited the Radersburg Methodist Church and learned about Brother Van Orsdell and the preacher's circuit. From there the students went to the Radersburg cemetery – the second favorite part of the field trip. BCDC Committee Updates

All the committees that came out of the Community Review process have been meeting on a mostly regular monthly basis. These committees are the Affordable Housing, Childcare, CARB (Community Advisory and Research Building) committee which could also be converted to (Community Activities and Recreation Building), Trails, and Broadband committees. The Broadband committee answers to the County commissioners but is funded, as are the others, through BCDC.

The Affordable Housing committee has been struggling with the same issues as everyone else in Montana and the Nation also. I don't think there is much to report on here yet. The Childcare committee has received a \$5000 grant to hire a coordinator. Sounds she has been busy and doing a good job.

The Trails committee has been progressing and is close to putting on some public meetings about the Trails Master Plan. Committee members have been tasked with providing details on priority trails so that is about done. The number one priority is a pedestrian bridge over the Missouri north of Townsend. It may be an attached bridge or a standalone. We will have to see which is most affordable and achievable. Either way, it will cost a few million. We will be looking for grants to achieve this and other funding.

The CARB committee has been doing mostly research and talking with potential consultants. We are getting closer to search for funding to possibly hire a consultant firm to put together a business or feasibility plan. There have been some good projects around the country that have benefited from these preliminary studies and plans. The plans that we have seen from other areas are extensive, looking at demographics, costs, both for construction and maintenance, and possible income to sustain a center. We will be talking with some of these consultants soon to receive quotes on the cost of a plan. We have not determined a location yet either.

Some of you may have been wondering about the webcam (link is on the townsendmt.com website) that is attached to City Hall looking down Main Street in Townsend. It has been down since June and it has definitely been a process and costly learning experience trying to get it going again. The old camera turned out broken and to get the new one installed and formatted has been a nightmare. It still is not working properly so bear with us. We will eventually get the bugs worked out on it.

We have recently funded two Store Front Beautification grant requests, one for Townsend Hardware and one for Broadwater Beauty Boutique, both on Broadway. We are always happy to support our local businesses and their efforts to improve the looks of their businesses.

In addition, we are always looking for new members and are in the middle of our annual membership drive. Preserve Broadwater History

We started Preserve Broadwater History to augment the other historical organizations in Broadwater County. Our main focus is to restore and

preserve some of the historical buildings and sites in Broadwater County. However, raising funds for a huge project like the historic Johnson School House is a slow process. We are currently researching grants to potentially hire professionals to formulate a plan for relocating and then restoring the historical school.



In the meantime we have built a website to host three of the counties historical organizations: Radersburg Historical Preservation, Inc, Broadwater County Museum and Preserve Broadwater History. We have gathered information about the Johnson Schoolhouse (thank you Peggy Flynn) and have placed pictures, articles, and historical information from RHPI and the County Museum on one website.

Working with Radersburg Historical Preservation, Inc., the Broadwater County Museum and Preserve Broadwater History organized the 3rd annual Radersburg history fieldtrip for the Townsend Schools middle school class. The students visited Radersburg to learn about the history of Radersburg. They visited the Radersburg School and were given a presentation about Radersburg from Broadwater County Museum Curator Linda Huth. After a lunch of burgers and hotdogs, the students then visited the Radersburg Methodist Church and the Radersburg Cemetery where they had a short presentation from Jackie Smith.

kids are happy doing pottery, sewing, and robotics currently.

The Pottery Guild - Teddy Lewis has been doing an extraordinary job in the Pottery Guild, instructing classes for the school and adult members. STOKE is currently partnering with the school to provide four classes a week under their 21st Century program with an average of 6 – 10 students per class. Students are learning how to wedge clay, throw a bowl on one of our eight wheels, do some hand building, roll clay with our slab roller, and glazing their pottery piece along with other assorted steps in the pottery process. Teddy does all the firing of the pieces as this a fairly technical

process. It's interesting the level of artistry the kids are producing. We are also getting some adults paying for a membership in the guild. These memberships help us with some of the costs in keeping this guild functional and also paying for the students who are not involved in the 21st Century afterschool program. We definitely have room for more adults in the guild. Memberships are \$65/month plus \$30 for a box of clay. Contact Teddy Lewis at 406-439-9345 or just come down to the guild at 108 N. Spruce to see what's going on. He's usually down there most of the time except Thursday and Sunday.

Laura Frazier's Sewing Sisters Club is making tie skirts, using men's ties for their fashion design. If you have any extra ties, she is still looking for more. You can contact any of the board members for drop off.

Board member Spencer Sellay and his co-coach, Roger Flynn, have been working hard to get the FIRST Lego League and the FIRST Tech Challenge kids ready for competition this month and next. There are nine kids in FLL and two currently in the FTC group. The FLL kids have been working on a presentation, required for the program, that deals with Sleep, their choice. We have seen the draft version and it's spectacular. Dr. Lisa Brown has been helping them, but the kids have done most of the work. The kids' robotics project is coming along nicely and are expected to make it to the state competition. So far, it's been a great year for the robotics teams. For the kids who participate in FTC, the possibility of some great scholarships in the tech world are possible.

We soon are going to sponsor some media arts clinics through an organization called MAPS Media Arts Institute. Other Montana schools and organizations have sponsored these clinics for middle and high school level youth, producing professional level videos, podcasts, and other mediaoriented projects. We are hoping to sponsor three clinics this year. MAPS provides all the needed equipment and professional instructors to deliver a five-star clinic. Three of these clinics will cost us over \$8000 but we hoping to try for some grants to cover these most of these costs.

In the past years, we were able to sponsor several Snapology classes for grades 3-8. The gal that owned the Snapology franchise had to sell her business, so we were without that program. She did offer us some of the robotic kits, iPads, and other equipment necessary to offer our own classes. Since purchasing this equipment, we will soon be offering these classes for grades 3-5. These classes are very good training for the kids who will want to move into the FIRST Lego League as they move into middle school. Jasmine Ankerstjerne will be instructing the classes for us this year.

We are looking at other programs this year and will start some of them soon. Cooking, an outdoor program, and others that are on our radar will be starting also. Keep an eye on our new re-designed website, stokemt.org, for more information.

Game Night is available again for all ages with ping pong, pool, foosball, STOKE board directors are looking forward to another great year. Our cornhole, chess, and karaoke are all popular. Game Night is on the second and fourth Thursday 5:30 - 7:30. Snacks or pizza is available for all who come. Families are encouraged but not necessary. Any kids 10 or under are required to have an adult in attendance.

Stalking: Homicide in Slow Motion

Stalking is a pattern of behavior directed at a specific person causing them fear for their physical or psychological safety. For very good reasons, stalking has been described by some experts as "homicide in slow motion." This owes partly to a well-documented correlation between stalking and the risk of intimate partner homicide. But the comparison to homicide also refers to the way stalking can rob a survivor of their basic sense of life and autonomy.

Much like other forms of control, abuse, and intimidation, the seriousness of stalking is widely underestimated and misunderstood, thanks in no small part to the way it's represented in our culture. In popular media, for example, stalking is portrayed casually—sometimes as a sign of harmless infatuation with, or deep affection for another person. In reality, stalking is extremely dangerous, and misattributing it to admiration or love obscures its defining characteristic: the terror and harm it causes victims.

With January being Stalking Awareness Month, The Friendship Center invites our community to learn about the signs, prevalence, and seriousness of stalking from one of our advocates. Written by Jaime Gabrielli, this piece highlights key facts to know about this crime, how we can all support survivors, and what our staff advocates can do to help those who experience stalking.

Prevalence and Tactics

It's estimated that at least 13.5 million individuals in the U.S. are survivors of stalking every year. For perspective, that's about double the population of Arizona. And most of those survivors are women. Like other interpersonal crimes (i.e., domestic violence, sexual assault), we know that stalking is underreported. That is notable because the data we do have suggests that stalking is widespread, and yet, it still probably represents an *undercount* of its prevalence.

In most cases, **stalkers are known to their victims**. About 61% of females and 44% of males experiencing stalking are victimized by a current or former intimate partner. Most stalkers use multiple tactics, leaving victims unable to know when they are being watched, or where they can find safety in their everyday lives.

Stalking can take many forms, including:

- Unwanted phone calls, texts, emails, or social media messages
- Cyberstalking, or exploitation of the internet or technology
- Unwanted gifts or love letters left at a survivor's home, workplace, or vehicle
- Watching or following from a distance
- Monitoring through a third party (i.e., friends, neighbors, coworkers)
- Posting threatening or personal information about a victim on the internet
- Spying on someone using a listening device, hidden camera, apps, or software
- Using a cell phone tracker or GPS device to monitor location
- Contacting friends, family, or coworkers to intimidate or manipulate
- Leaving personal, significant, or potentially dangerous objects for the victim to see
- Property damage
 Threats of harm

Take Stalking Seriously and Validate Survivors

Stalking is a criminal offense and there is *never an excuse* for it. It destroys the survivor's quality of life, sense of wellbeing, and personal safety. Their responses are attempts to protect themselves and their loved ones from future harm. It is important for us all to understand and convey to survivors that their concerns are valid, and they are never to blame for their stalker's actions.

Stalking is not only terrifying and emotionally distressing for victims; it can also be deadly. Research indicates **stalking is a greater risk factor for intimate partner homicide than other forms of intimate partner violence**. As advocates, we are trained to take stalking seriously and educate victims about potential risks and necessary safety planning. We know that stalking after a victim leaves or attempts to leave increases

We know that stalking after a victim leaves or attempts to leave increases their risk of experiencing future violence and even being killed at the hands of their partner. One of the most sobering statistics we keep in mind when working with stalking victims is that more than 76% of femicide victims were stalked prior to being killed.

It Is Harder to Leave an Abuser Who Stalks

Stalking is not just a concern after a person escapes an abusive relationship. Studies show 74% of those stalked by a former intimate partner reported violence and/or coercive control during the relationship. Domestic violence victims are commonly stalked before they try to leave, making it more difficult to get away. Concerns about nonconsensual image sharing (often referred to as "revenge porn"), online harassment, financial sabotage, increased monitoring, and threats of violence are a few of the reasons stalking victims feel unsafe leaving their abusers.

Survivors often tell us it is safer for them and their children to remain with the abuser to prevent further harm and acceleration of abusive behaviors. Because of these added barriers, those stalked by violent partners report more attempts to leave their abusers than partner violence victims who are not stalked.

Stalking in abusive relationships is a deeply complex issue with no easy solutions. Victims struggle with how to respond to their stalkers without increasing their risk of further harm. They may try reasoning with their abuser to placate them, hoping that "being nice" will make the behavior stop. It is normal for victims to minimize their experiences, telling themselves, "It's not that bad." Out of desperation, some even try to confront or threaten the stalker or attempt to "fight back."

Individuals impacted by the crime of stalking frequently feel alone, confused, and powerless. Recent studies report that nearly a third of stalking victims say they fear the stalking will never stop. As a result of the persistent terror, victims of stalking suffer much higher rates of depression, anxiety, insomnia, and social difficulties than the general population. For many, having access to the right type of supportive resources can be the difference between hope and hopelessness, and even life and death. That's where agencies like The Friendship Center can help.

Confidentiality, Accurate Information, Support, and Agency

Victims are not in control of their abusive partner's behavior and often don't know where to turn for help. They need accurate information about their options and legal rights and deserve to be respected as experts in their own lives. Stalking survivors have the right to be informed, supported, and empowered to take steps to keep themselves and their loved ones safe, whether they choose to remain in the relationship or not.

Stalkers can be unpredictable and dangerous; addressing safety concerns needs to be an informed, adaptive, and ongoing process. At The Friendship Center, our advocates are trained to approach each situation as unique because we know there is no single effective approach survivors can rely on to remain safe.

It is vital that victims are aware of confidential services like ours in their own community, where skilled advocates can help them create individualized safety plans and offer ongoing support.

Resources for Survivors

Whether or not a survivor seeks the help of an agency like The Friendship Center, there is a wealth of free online resources they can access and steps they can take to help with safety planning. This list of tools and actions we often use with our clients is not exhaustive, but can help survivors understand their risks, make decisions, and plan their next steps:

Stalking and Harassment Assessment and Risk Profile (SHARP)

- This web-based assessment provides a big picture evaluation of a survivor's circumstances and can help address a wide variety of safety concerns. (thefriendshipcenter.org/sharp)

<u>Protective orders</u> – Montana Law Help's FAQ on Orders of Protection provides an overview on protective orders in Montana, how to get one, how to prepare for court, and what to do after your hearing. The Friendship Center can also provide survivors with information about filing protective orders and reporting options. (thefriendshipcenter.org/protective-order)

Stalking log – Survivors can use this tool to document incidents of stalking and create a record of the abuse. Logs like this can help establish the pattern of behavior that defines stalking.

<u>Documentation</u> – It's up to a survivor to choose whether they want to report stalking to authorities or request a protective order. Regardless, saving all voicemail, text, social media, and email messages sent by the stalker can be important evidence to present for law enforcement reports and requesting protective orders. Saving as much evidence as possible (or forwarding it to a safe person or email address) can help a survivor make a delayed report, or plan for their safety if they choose to work with an advocate later.

Broadwater County Mental Health

Mental/Behavioral Health has been an important topic of conversation in recent years. According to The National Alliance on Mental Health, in February 2021 there were 163,000 Montana adults with a mental health condition and 47,000 of those adults went without needed mental health care.

The Broadwater County Public Health Department was recently awarded a grant from Montana Healthcare Foundation to help address the mental health crisis system in Broadwater County. Over the next 18 months of the grant, we will be gathering mental health related data for Broadwater County and mapping current resources. With this data we will be able to identify gaps and needed services and develop a strategic plan for an effective and sustainable behavioral health crisis system for our community.


