The Broadwater Community Foundation (BCF) provides grants to charitable projects in Broadwater County. BCF has been making grants to the community since 1996 and has donated \$338,189.90 locally through Sept. 2024.

## ELIBILITY

### Projects must:

- ✓ Be charitable in purpose.
- ✓ Have able and committed leadership.
- ✓ Be a 501(c)(3), 509(a)(1), (2), (3) or (4) nonprofit corporation or a government entity (county, city, school)

### Ineligible Projects:

- ✓ Conferences and workshops.
- ✓ Planning, research or untested projects.
- ✓ Partisan or sectarian activities.
- ✓ Projects that benefit an individual.

## ABOUT THE GRANTS

- ✓ Grant sizes will be approximately \$500 to \$3,000.
- ✓ Grants must be for projects that benefit communities and residents of Broadwater County.
- ✓ Grant requests are reviewed by the Board of Directors of the Broadwater Community Foundation.
- ✓ Incomplete applications will not be considered.

## PREFERRED PROJECTS Priority will be given to projects that meet the following criteria

- ✓ Provide a long-term and direct benefit to local residents.
- ✓ Have support from other community members and/or organizations.
- ✓ Address important and unmet needs.
- ✓ Help to build a better and/or thriving community.
- ✓ Projects have an ongoing, sustainable funding source.
- ✓ Improve the quality of life for local residents.

## MATCHING FUNDS CASH MATCH IS REQUIRED FOR GRANTS

- ✓ For every five dollars of grant funding applicants must have at least a one dollar CASH match for the project (5:1). Please include some form of evidence of the cash match (letter of commitment or a copy of a donation received).
- ✓ In-Kind match (committed materials, donated time, etc.) are valuable and show the commitment and importance of the project to the community. Please describe any in-kind match committed to the project.

## APPLICATION PACKAGE CHECKLIST Please include the following items in your application

- ✓ Broadwater Community Foundation Grant Application Cover Sheet.
- ✓ Project budget.
- ✓ Copy of your 501(c)(3) or 509(a) 1-4 status (if not a government entity).
- ✓ Description of cash and in-kind match and evidence that cash and in-kind match are committed to the project.
- ✓ Roster of board members or project leaders.
- ✓ A written description of the proposed project, in two pages or less, to include the following:
  1. A detailed description of the proposed project.
  2. Explanation of how the project meets the BCF's funding priorities (see above).
  3. Describe the impact of the project in the community.
  4. Estimate how many people will benefit from this project.
